

AUTO-RENEWAL SUBSCRIPTION AGREEMENT

(自动续费订阅协议)

This Auto-Renewal Subscription Agreement (“Agreement”) applies to all auto-renewing subscriptions offered by **[Company Name]** (“Company”, “we”, “us”).

By purchasing an auto-renewing subscription, you acknowledge and expressly agree to the terms set forth below.

1. Subscription Description

1. This subscription provides access to **membership benefits, privileges, or digital services** offered by the Platform.

3.1 App Store / Google Play Purchases

3.2 Web or Third-Party Payments (if applicable)

2. Renewal charges will be processed automatically unless canceled.

4. Subscription Management & Cancellation

1. You may manage or cancel your subscription at any time through:
 - **Apple ID Settings** → Subscriptions;
 - **Google Play Store** → Payments & subscriptions; or
 - Your account settings on the Platform (if applicable).
2. Cancellation will take effect **at the end of the current billing period**.
3. Deleting the app does **not** cancel your subscription.

5. Pricing Transparency

1. The subscription price, billing cycle, and auto-renewal terms are **clearly**

disclosed prior to purchase.

2. Prices may vary by region and are subject to applicable taxes.
3. Any price changes will apply only to future subscription periods and will be disclosed in advance where required by law.

6. No Refund Policy

2. Refund requests for App Store purchases must be submitted directly to **Apple**.
